## CITY RESOLUTION NO. 2009-001

A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO AN AGREEMENT WITH THE ANTIPOLO PUBLIC MARKET VENDORS ASSOCIATION (APMAVA) PERTINENT TO THE IMPOSITION AND COLLECTION OF WATER CHARGES FROM THE STALL RENTERS OF THE CITY PUBLIC MARKET OF ANTIPOLO AND FOR OTHER PURPOSES.

**WHEREAS,** in December , 2007, the Antipolo Public Market Association (APMAVA) members, in their desire to maintain the sanitation of the public market initiated the installation of pipe lines and water meters of their individual stalls out of their own expenses;

**WHEREAS,** on June 18, 2008, a committee hearing was conducted by the Committee on Ways and Means corresponding to the request of the City Market Division for an appropriate legislation for the purpose of collection of the cost of water consumption of the City Public Market of Antipolo stall renters. Due to some unresolved issues, another committee hearing was conducted on September 3, 2008 resolving all the issues entailed by the water bill collection;

**WHEREAS,** in consideration to the initiative of APMAVA to install water pipe lines and meters out of their own expenses, the City Government deemed it right to enter into an agreement with the APMAVA, for the City to be able to collect water charges, stipulating therein all the conditions favorable to both parties;

**WHEREAS,** an authority from the Sangguniang Panlungsod for the Local Chief Executive to represent the City Government is necessary as provided in Article 86, paragraph (b), sub-paragraph (1), (vi) which reads:

ART. 86. Powers, Duties and Functions of the City Mayor. - (b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall:

(1) Exercise general supervision and control over all programs, projects, services and activities of the city, and in this connection, shall:

(vi) Represent the city in all its business transactions and signs in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;

**NOW THEREFORE,**


