**WHEREAS,** Administrative Order No. 09 series of 2002 issued by the Department of Agriculture to encourage the PARTICIPATION OF RURAL BASED ORGANIZATIONS IN THE ACTIVITIES AND SUPPORT THEREOF states that, in order to provide more impetus to revitalize and sustain the organization of farmers, fisherfolk, livestock and poultry raisers, RIC , 4-H Club members and their activities to make them functional and productive partners of the Department of Agriculture (DA), the Administrative Order is hereby issued;

**WHEREAS,** such assistance to people's and non-governmental organizations needs the concurrence of the Sanggunian concerned;

**WHEREAS,** the Federated Rural Improvement Club (RIC) is a voluntary civic organization which started in 1972 and has been properly accredited as non-government organization by the Office of the Sangguniang Panlungsod;

**WHEREAS,** the Federated Rural Improvement Club of Antipolo City is requesting an amount of Three Thousand Pesos for each of thirteen (13) RIC volunteer teachers for their monthly allowance to sustain their daily needs for transportation and other expenses;

**WHEREAS,** the thirteen (13) existing RIC Centers would want to continue their operation, thus, the amount of Thirty Nine Thousand Pesos (Php 39,000.00) per month is needed to provide the RIC Center volunteer teachers for their allowance, and likewise to ensure that the RIC program will be sustained by maintaining its teachers.

**NOW THEREFORE,**

**ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED,** to authorize the allocation of funds for the allowances of thirteen (13) Volunteer Teachers of the existing RIC Centers in Antipolo City.


**RESOLVED FURTHER,** that the amount to be defrayed for the above-stated purpose shall be subject to the availability of funds.




