CITY RESOLUTION NO. 2009-005

A RESOLUTION EXTENDING THE DEADLINE FOR THE PAYMENT WITHOUT SURCHARGE OR PENALTY OF ANNUAL BUSINESS FEES AND TAXES IN THE CITY OF ANTIPOLO TO JANUARY 31, 2009.

WHEREAS, under the provisions of law, local taxes and charges, owing the local government shall be paid within the first 20 days of January of each year;

WHEREAS, owing to the existing national economic difficulties affecting business, a substantial number of businesses may not be able to meet the deadline for payment without surcharges or penalties;

WHEREAS, considering the long vacation during the Christmas Season, it is the clamor of the paying businessmen of this city to allow them an extension of time for them to be able to comply with the requirements for the filling of their applications for business permits and licenses;

WHEREAS, considering that a lot of our taxpayers are working some of whom in areas far from our city, an extended time of service is necessary for us to collect effectively;

WHEREAS, the Sangguniang Panlungsod is authorized by law, to extend such payment without penalties or surcharges for justifiable reason or cause as provided in Article 295 of the Rules and Regulations Implementing the Local Government Code of 1991 as follows:

ART. 295. Time of Payment. – Unless otherwise specifically provided in this Rules, all local taxes, fees and charges due and accruing to the LGUs shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, or charges without surcharges or penalties but only for a period not extending six (6) months:

WHEREFORE, after due deliberation, on motion duly seconded, be it resolved, as it is hereby resolved, to extend as it is hereby extended, the payment of business taxes without surcharges or penalties to January 31, 2009 in the City of Antipolo.

BE IT REOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF ANTIPOLO, IN SESSION ASSEMBLED THAT:

SECTION 1. Extension of Period of Payment. Payment of business fees and taxes is extended up to January 31, 2009 without surcharge or penalty.

SECTION 2. Extension of Working Hours. The BPLO and other concerned office shall work at "No Lunch Break" basis and shall work overtime for as long as there are payers willing of their services during week days, provided that it will not exceed 10:00 P.M. and 8:00 A.M. to 5:00 P.M. on Saturdays to surely give our payers ample to pay from January 20-31, 2009.


