CITY RESOLUTION NO. 2009-006

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO NEGOTIATE WITH RODOLFO C. GALLARDO, THE REGISTERED OWNER OF A PARCEL OF LAND CONTAINING AN AREA OF 48,076 SQUARE METERS, SITUATED AT SITIO KALAKAD, BARANGAY INARAWAN, ANTIPOLO CITY, EMBRACED IN TCT NO. R-51296 FOR THE ACQUISITION OF A PORTION OF SAID LAND MEASURING 40,000 SQUARE METERS, THROUGH PURCHASE, FOR PUBLIC USE OR PURPOSE.

WHEREAS, Mr. Rodolfo C. Gallardo, married to Ma. Teresita G. Gallardo, is the registered owner of a parcel of land situated at Sitio Kalakad, Barangay Inarawan, Antipolo City, embraced in TCT No. R-51296 and containing an area of 48,076 square meters, more or less;

WHEREAS, the acquisition of the said property can be used as relocation site or area for the families affected by the clearing/demolition operations undertaken by the DPWH and the City along Circumferential Road and Marcos Highway;

WHEREAS, in order to enable the City Mayor to validly undertake such negotiation, there is a need for the adoption of a resolution authorizing the local chief executive to conduct such negotiation;

WHEREAS, considering the pressing need for providing location site for the families affected by the said demolition/clearing operations, this august body has unanimously agreed to adopt this resolution.


ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED , BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to authorize , as it is hereby authorized, the Hon. Danilo O. Leyble, City Mayor to negotiate with Rodolfo C. Gallardo, the registered owner of a parcel of land containing an area of 48,076 square meters, situated at Sitio Kalakad, Barangay Inarawan, Antipolo City, embraced in TCT No. R-51296, for the acquisition of a portion of said land measuring 40,000 square meters, through purchase, for public use or purpose.
