WHEREAS, on September 17, 2008, Barangay San Jose enacted Tax Ordinance No. 01 , Series of 2008 known as "Revenue Code of Barangay San Jose, Antipolo City, a copy of which is made an integral part of this resolution;

WHEREAS, in compliance to Section 57 (a) subject Tax Ordinance was submitted to the Sangguniang Panlungsod of Antipolo for purpose of review but was returned back to its origin barangay for appropriate modification as recommended by the reviewing committee , having found partly inconsistent with the applicable provisions of the Local Government Code of 1991;

NOW THEREFORE,


