### CITY RESOLUTION NO. 2009-016

A RESOLUTION APPROVING THE APPLICATION OF FBM CONSTRUCTION AND AGRO-INDUSTRIAL CORP. FOR THE ISSUANCE OF DEVELOPMENT PERMIT ON ITS SUBDIVISION PROJECT KNOWN AS GOLDEN PALM RESIDENCE LOCATED ON SITIO KAILA, BARANGAY SAN ROQUE, ANTIPOLO CITY, INVOLVING AN AREA OF 6,599 SQUARE METERS, EMBRACED IN TCT NOS. N-128194 AND N-192244, REGISTERED IN THE NAME OF FBM CONSTRUCTION AND AGRI-INDUSTRIAL CORP. , PURSUANT TO THE PROVISIONS OF PD 957.

**WHEREAS,** Section 11 (e) (2) (j) of RA 8508, otherwise known as the "Charter of the City of Antipolo", provides:

(2). Generate and maximize the use of resources and revenues for the development plans, program objectives, and priorities of the City, with particular attention to agro-industrial development and citywide growth and progress:

(j). Subject to national law, process and approve subdivision plans for residential, commercial or industrial purposes, and to collect processing fees and other charges, the proceeds of which shall accrue entirely to the City: Provided, however, that where approval of a national agency or office is required, such shall not be withheld for more than thirty (30) days from receipt of the application. Failure to act on the application within the period stated shall be deemed as approval thereof;"

**WHEREAS,** the Committee on Housing and Land Utilization, to which was referred the application of FBM Construction and Agro-Industrial Corp. for the issuance of development permit on its subdivision project known as Golden Palm Residence located on Sitio Kaila, Barangay San Roque, Antipolo City, pursuant to the provisions of PD 957, has verified and considered the same and after proper examination and careful evaluation of the application and the pertinent papers attached thereto, the said committee has determined that the parcels of land on which the subdivision project is proposed to be put up are registered in the name of FBM Construction and Agro-Industrial Corp., and embraced in TCT Nos. N-128194 and N-192244, with Tax Declaration Nos. AA-001-09183 and AA-001-09184, respectively, containing an aggregate area of 6,599 square meters. Moreover, the committee has noted, based on the findings of the City Planning and Development Office (CPDO), that the applicant has substantially complied with the minimum requirements and standards prescribed for the project of this nature by existing laws, rules and regulations, and that the project applied for is not covered by the provisions of Section 18 of RA 7279. Furthermore, the committee has noted the favorable recommendation of the CPDO for the approval of the development plan and the issuance of the corresponding development permit, subject to the compliance with the policies and regulations of national agencies concerned. Finally, the committee has resolved that the compliance with the requirements for the issuance of the development permit shall be strictly monitored by the Technical Staff of the CPDO during the entire period of development until the final completion of the subdivision project, and that any false or fraudulent misrepresentation or concealment as to any material data on the part of the applicant shall constitute sufficient ground for the revocation of the development permit;

**WHEREAS,** taking into account the wide extent of the socio-economic benefits that will be generated by the subdivision project, particularly in relation to agro-industrial development and city wide growth and progress, this august body has recognized the need for the approval of the development plan as well as the application for the issuance of the development permit.

**NOW THEREFORE,**


