A RESOLUTION APPROVING FOR PURPOSES OF REVIEW BARANGAY DALIG RESOLUTION NO. 024, SERIES OF 2008 ENTITLED "A RESOLUTION AUTHORIZING THE PUNONG BARANGAY, HON. ENGR. CATALINO M. LEYVA TO ACCEPT THE DEED OF DONATION OF A ROAD RIGHT OF WAY CONTAINING AN AREA OF 550 SQUARE METERS, EMBRACED IN TCT NO. 225862, LOCATED IN SAN LORENZO ST., PARUGAN BLOCK II AND EXECUTED BY THE CHILDREN AND COMPULSORY HEIRS OF MERCEDES PARTOZA, NAMELY: LYDIA MARTINEZ DE JESUS, ARACELLI MARTINEZ BENITEZ, TERESITA MARTINEZ REGINO AND AGUILLIANA MARTINEZ SANTOS", FOR BEING CONSISTENT WITH LAW OR ORDINANCE.
