CITY RESOLUTION NO. 2009-021

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND EXECUTE, FOR AND IN BEHALF OF THE CITY, THE DEED OF DONATION INVOLVING A PARCEL OF LAND SITUATED IN BARANGAY SAN ISIDRO, ANTIPOLO CITY, OWNED BY THE KINGSVILLE CONSTRUCTION AND DEVELOPMENT CORPORATION, EMBRACED IN TCT NO. R-52328, CONTAINING AN AREA OF 876 SQUARE METERS, EXECUTED BY THE KINGSVILLE CONSTRUCTION AND DEVELOPMENT CORPORATION, IN FAVOR OF THE CITY OF ANTIPOLO, TO BE DEVOTED AS THE SITE OF A BARANGAY HALL ANNEX, AND FOR OTHER PURPOSES.

WHEREAS, the Kingsville Construction and Development Corporation is the registered owner of a parcel of land situated in Barangay San Isidro, Antipolo City, embraced in TCT No. R-52328, containing an area of eight hundred seventy six (876) square meters;

WHEREAS, the registered owner of the subject property has manifested its intention to donate the aforesaid parcel of land in favor of the City and has in fact executed a Deed of Donation for the purpose, copy of which is hereto attached and made as an integral part hereof;

WHEREAS, one of the conditions of the said donation is that the donee or the city shall use the above-mentioned parcel of land exclusively for the construction of a Barangay Hall Annex building and other improvements which are necessary and/or incidental for the construction of the Barangay Hall Annex;

WHEREAS, the City Government of Antipolo has likewise manifested its willingness to accept the said donation and, in consonance with the provisions of RA 8508 or the Charter of the City of Antipolo, and RA 7160 or the Local Government Code of 1991, the authority of the sangguniang panlungsod is necessary for the City Mayor to accept the donation;

WHEREAS, the acceptance of the donation of the aforementioned property will be beneficial to the interest of the City, pursuant to its program of government and for this reason, the adoption of a resolution conferring the necessary authority to the city mayor to accept the donation is hereby enjoined.

NOW THEREFORE,


ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to authorize, as it is hereby authorized, the Hon. Danilo O. Leyble, City Mayor, to sign and execute for and in behalf of the City, the Deed of Donation involving a parcel of land situated in Barangay San Isidro, Antipolo City, owned by the Kingsville Construction and Development Corporation, embraced in TCT No. R-52328, containing an area of 876 square meters, executed by the Kingsville Construction and Development Corporation, in favor of the City of Antipolo, to be devoted as the site of a Barangay Hall Annex, and for other purposes.


RESOLVED FINALLY, to furnish copies of this resolution to all concerned parties for their information and guidance.


