### CITY RESOLUTION NO. 2009-023

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES REGARDING THE CO-MANAGEMENT AND DEVELOPMENT OF THE HINULUGANG TAKTAK NATIONAL PARK, SITUATED AT BARANGAY DELA PAZ, ANTIPOLO CITY AND FOR OTHER PURPOSES.

**WHEREAS,** the Hinulugang Taktak National Park (HTNO) is presently being administered by the Protective Areas and Wildlife Bureau (PAWB) of the Department of Environment and Natural Resources pursuant to the provisions of Republic Act No. 6964 and the NIPAS Act;

**WHEREAS,** the HTNP has cultural and historical significance to the City of Antipolo since the City is closely associated with it. The National Park serves as one of its landmarks and significantly a rich source of the City's heritage;

**WHEREAS,** as mandated under R.A. 7160, "local government units shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction, subject to the provisions of this Code and national policies";

**WHEREAS,** the City of Antipolo, pursuant to City resolution No. 85-2001 has entered into a Memorandum of Agreement (MOA) with DENR-PAWB which provided for a cooperative and joint management and administration of the HTNP (Annex A1-A2);

**WHEREAS,** guided by the principle of shared-vision and co-management of the natural resource, the Local Government Unit of Antipolo City, represented by the Hon. Danilo O. Leyble, City Mayor, needs to enter into a MOA between the City and DENR which shall strengthen and institutionalize the co-management and administration of the HTNP (hereto attached as ANNEX A3);


**WHEREAS,** in order to execute the MOA, it is necessary that an authority be given to the City Mayor pursuant to the provisions of the Local Government Code of 1991;


**N O W T H E R E F O R E ,** after due deliberation, on motion duly seconded, be it resolved, as it is hereby resolved, to authorize the Hon. Danilo O. Leyble, City Mayor as he is hereby authorized, to enter into a Memorandum of Agreement, in behalf of the City of Antipolo, with the Department of Environment and Natural Resources regarding the administration and management of the Hinulugang Taktak National Park (HTNP) the terms and conditions of which is substantially covered by Annex A3 of this resolution.


