CITY RESOLUTION NO. 2009-028

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, FOR AND IN BEHALF OF THE CITY TO NEGOTIATE FOR THE ACQUISITION OF A PORTION MEASURING 3,000 SQ.M. OF A PARCEL OF LAND LOCATED AT TAKTAK ROAD (NINOY AQUINO AVENUE), BARANGAY DELA PAZ, ANTIPOLO CITY, OWNED BY AND REGISTERED IN THE NAME OF L. C. LOPEZ RESOURCES, INC., EMBRACED IN TCT NO. R-20324, CONTAINING A TOTAL AREA OF 3,921 SQUARE METERS, TO BE USED AS THE SITE FOR THE PROPOSED CONSTRUCTION OF THE BARANGAY DELA PAZ HIGH SCHOOL BUILDING, AND FOR OTHER PURPOSES.

WHEREAS, in a letter dated January 14, 2009 of Lolito S. Lopez of L. C. Lopez Resources, Inc., addressed to the Hon. Danilo O. Leyble, City Mayor, copy of which is hereto attached and made as an integral part hereof, Mr. Lopez offered to sell to the City a portion of the property measuring 3,000 sq.m. situated at Taktak Road, beside the Montessori Integrated School Academy, owned by and registered in the name of L. C. Lopez Resources, Inc., embraced in TCT No. R-20324, containing a total area of 3,921-square meters, which is an ideal site for the proposed construction of the Barangay Dela Paz High School Building;





WHEREAS, the aforesaid letter was subsequently referred to the Committee on Housing and Land Utilization for appropriate action and the said committee in turn submitted a committee report strongly recommended favorable action by the sangguniang panlungsod taking into consideration the educational needs of the people of Barangay Dela Paz who has been longing for a high school building in their locality for quite a time already;

WHEREAS, pursuant to Section 7 of the Charter of the City of Antipolo (RA 8508), the city is mandated to provide the basic services and facilities under Section 17 of the Local Government Code of 1991 (RA 7160) which includes "infrastructure facilities intended to service the needs of the residents of the City including x x x school buildings and other facilities for public elementary and secondary schools";

WHEREAS, taking into account the wide range of benefits that will redound to the city and its constituents in the event the putting up of the subject high school building in Barangay Dela Paz is successfully undertaken, this august body has recognized the pressing necessity of conferring the necessary authority to the local chief executive to achieve the abovementioned objective.

NOW THEREFORE,


ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED , BE IT RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED , to authorize, as it is hereby authorized, the Hon. Danilo O. Leyble , City Mayor, for and in behalf of the City, to negotiate for the acquisition of a portion measuring 3,000 square meters of a parcel of land located at Taktak Road (Ninoy Aquino Avenue), Barangay Dela Paz, Antipolo City, owned by and registered in the name of L. C. Lopez Resources Inc., embraced in TCT No. R-20324, containing a total area of 3,921 square meters, to be used as the site for the proposed construction of the Barangay Dela Paz High School Building, and for other purposes.




