A RESOLUTION ENDORSING THE EXTENSION OF SERVICES OF MANILA WATER COMPANY FOR ANOTHER MORE YEARS NECESSARY TO CONTINUE AND COMPLETE ITS CAPITAL EXPENDITURES PROGRAM FOR WATER SERVICES EXPANSION, REALIBILITY AND SUSTAINABLE DEVELOPMENT AND FOR OTHER PURPOSES .

WHEREAS, it is well-enshrined in Sec. 2, Article XII of the 1987 Philippine Constitution that the state owns the natural resources which will include all waters , lands of public domain, minerals, among others. The exploration, development and utilization of these natural resources shall be under the full control and supervision of the State;;

WHEREAS, as mandated under Section 16 of R.A. 7160, otherwise known as "The Local Government Code of 1991", every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;
