CITY RESOLUTION NO. 2009-030

A RESOLUTION APPROVING THE APPLICATION OF RIVERSIDE HOMEOWNERS ASSOCIATION, INC. FOR THE ISSUANCE OF ALTERATION PERMIT ON ITS SUBDIVISION PROJECT KNOWN AS RIVERSIDE SUBDIVISION LOCATED AT H. ALARCON ST., BARANGAY DELA PAZ, ANTIPOLLO CITY, EMBRACED IN TCT NO. 218349, WITH DEVELOPMENT PERMIT NO. 2001-0013 (BP 220) ISSUED ON SEPTEMBER 21, 2001, INVOLVING AN AREA OF ALTERATION OF 2,786 SQUARE METERS.

(2). Generate and maximize the use of resources and revenues for the development plans, program objectives, and priorities of the City, with particular attention to agro-industrial development and citywide growth and progress:

x x x x x x x x x

(j). Subject to national law, process and approve subdivision plans for residential, commercial or industrial purposes, and to collect processing fees and other charges, the proceeds of which shall accrue entirely to the City: Provided, however, that where approval of a national agency or office is required, such shall not be withheld for more than thirty (30) days from receipt of the application. Failure to act on the application within the period stated shall be deemed as approval thereof;"

WHEREAS, the Committee on Housing and Land Utilization, to which was referred the application of Riverside Homeowners Association, Inc. for the issuance of alteration permit on its subdivision project known as Riverside Subdivision located at H. Alarcon St., Barangay Dela Paz, Antipolo City, has verified the same and after careful examination of the application and the pertinent papers attached thereto, the said committee has determined that the land which are the subject of the subdivision project are embraced in TCT No. 218349, and that the applicant applied for and was issued Development Permit No. 2001-0013 (BP 220) on September 21, 2001. Moreover, the committee has determined that the affected area of alteration is 2,786 square meters and that the alteration particulars are as follows:

NATURE OF ALTERATION:

- I. Re-Blocking for Additional Road Alleys
Area covered : 2,786 square meters

Furthermore, the committee has ascertained, based on the findings of the City Planning and Development Office (CPDO) that the applicant has substantially complied with the minimum requirements and standards prescribed for the project of this nature existing laws, rules and regulations. Finally, considering the favorable recommendation of the CPDO for the approval of the alteration of the development plan and the issuance of the corresponding alteration permit, subject to the compliance with the policies and regulations of national agencies concerned, this committee has unanimously resolved likewise to strongly recommend the approval of the application for the issuance of the alteration permit which was adopted by the city council, subject to the condition that any false or fraudulent misrepresentation or concealment as to any material data on the part of the applicant shall constitute sufficient ground for the revocation of the alteration permit;

WHEREAS, considering the wide extent of the socio-economic benefits that will be generated by the subdivision project, particularly in relation to agro-industrial development and city wide growth and progress, this august body has recognized the need for the approval of the alteration of the development plan as well as the application for the issuance of the alteration permit.

NOW THEREFORE,

ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to approve, as it is hereby approved, the application of Riverside Homeowners Association, Inc. for the issuance of alteration permit on its subdivision project known as Riverside Subdivision located at H. Alarcon St., Barangay Dela Paz, Antipolo City, embraced in TCT No. 218349 with Development Permit No. 2001-0013 issued on September 21, 2001, involving on area of alteration of 2,786 square meters.
