CITY RESOLUTION NO. 2009-045

A RESOLUTION ALLOWING THE CONSTRUCTION OF A MULTI-PURPOSE HALL AT THE SITE OWNED BY THE CITY PARTICULARLY SITUATED AT LOT 1 BLOCK 36 PHASE 3A, BAGONG NAYON II, BARANGAY SAN ISIDRO , ANTIPOLO CITY, TO BE UNDERTAKEN AND FUNDED BY THE RIZAL PROVINCIAL GOVERNMENT.

WHEREAS, in a letter of Mr. Mariano A. Olivo, Founding Chairman of the Bayan ng Rizal (Philippines) Kaunlaran Dapat Sakatuparan (BARKADA'S) Inc., with address at Blk. 37, Lot 30, Phase 3-A, Bagong Nayon 2 , Barangay San Isidro, Antipolo City, addressed to Engr. Matienzo, City Planning and Development Coordinator, copy of which is hereto attached and made as an integral part hereof, Mr. Olivo requested the City Planning and Development Office (CPDO) for the issuance of a certification to the effect that the site of the proposed multi-purpose hall to be undertaken by the Rizal Provincial Government particularly Lot 1, Blk. 36, Phase 3A, Bagong Nayon 2, Barangay San Isidro, this City was turned over to the City and that the said certification is one of the requirements of the Rizal Provincial Government prior to the approval of the requested project;

WHEREAS, acting on the said request, the CPDO, thru its City Planning and Development Coordinator, Engr. Rene Matienzo, submitted a report dated February 10, 2009 addressed to the Sangguniang Panlungsod, thru the Hon. Jesus Angelito Y. Huertas, Jr., Chairman of the Committee on Housing and Land Utilization, copy of which is likewise hereto attached and made as an integral part hereof, informing the august body that then Municipal Council of Antipolo adopted Resolution No. 104-94 entitled "Authorizing the Municipal Mayor Daniel S. Garcia to Accept for and in Behalf of the Municipality of Antipolo, Rizal all the Completed Infrastructure Projects of the National Housing Authority (NHA) Particularly in Bagong Nayon II, Antipolo, Rizal such as roads, foot paths, alleys, drainage water systems and play areas", and that pursuant to the said Resolution No. 104-94, the subject site was among the Block Faucets that was turned over by the National Housing Authority in favor of the then Municipality of Antipolo, hence, the site is now a public property;

WHEREAS, the CPDO could not act on the request of the said association since the putting up of a multi-purpose hall is not in accordance with the designated use of the area as block faucet for which reason, the CPDO has recommended to refer the said matter to the Sangguniang Panlungsod for appropriate action, i.e., for the august to adopt a resolution allowing the construction of such day care center on the area designated as block faucet;

WHEREAS, acting on the CPDO recommendation, the Committee on Housing and Land Utilization, to which was referred the same matter for appropriate action, submitted a committee report adopting the recommendation of the CPDO and strongly recommended the adoption for the purpose.

NOW THEREFORE,


ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to allow, as it is hereby allowed, the Construction of a Multi-Purpose Hall at the site owned by the City particularly situated at Lot 1 Block 36 Phase 3A, Bagong Nayon II, Barangay San Isidro, Antipolo City, to be undertaken and funded by the Rizal Provincial Government, and for other purposes.
