**A RESOLUTION AUTHORIZING THE PUTTING-UP OF THE ANTIPOLO CITY CREMATORIUM ON STO. NIÑO STREET, BARANGAY SAN JOSE, ANTIPOLO CITY, AND FOR OTHER PURPOSES.**

**WHEREAS,** in this time and age, due to practical and fiscal reasons, more and more people are being interested in and resorting to the cremation of the remains of their loved ones instead of the traditional way of burying their dead relatives;

**WHEREAS,** due to the rapid escalation in the prices of burial lots as well as the costs in constructing and/or renting niches, our people now find it had to look for affordable burial sites to bury the remains of their dearly departed loved ones;

**WHEREAS,** recently, the statistics in terms of human mortality due to various reasons have gone up such that the problem of congestion in our cemeteries, both public and private, has exacerbated in such short a time;

**WHEREAS,** in order to address squarely and effectively the foregoing concerns, the city, consistent with its mandate to promote the general welfare through the delivery of basic services and facilities as embodied in Section 17 of the Local Government Code of 1991 (RA 7160) and Section 7 of the Charter of the City of Antipolo (RA 8508), has recognized the pressing necessity for the putting up of a crematorium in one of the public cemeteries and one such ideal site is the public cemetery on Sto. Niño Street, Barangay San Jose, Antipolo City;

**WHEREAS,** considering the wide range of benefits that will redound to the City and its constituents from the establishment of such crematorium, this august body has unanimously agreed to authorize the putting-up of the same.

**ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED , BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED ,** to authorize , as it is hereby authorized , the putting-up of the Antipolo City Crematorium on Sto. Niño Street, Barangay San Jose, Antipolo City, and for other purposes.
