### CITY RESOLUTION NO. 2009-059

**A RESOLUTION DECLARING THE AUGMENTATION OF APPROPRIATION OF BARANGAY SAN ISIDRO, ANTIPOLO CITY, INVOLVING THE AMOUNT OF FORTY FIVE THOUSAND (Php45,000.00) PESOS , AS APPROVED BY THE SANGGUNIANG BARANGAY UNDER APPROPRIATION ORDINANCE NO. 06-2008 DATED DECEMBER 05, 2008, AS OPERATIVE AS OF THE DATE OF ITS APPROVAL.**

**WHEREAS,** on December 05, 2008, the Sangguniang Barangay of San Isidro, Antipolo City, enacted Appropriation Ordinance No. 06-2008 through the adoption of Resolution No. 24-2008 entitled "Resolution to Re-aligning the Available Fund Amounting to Forty Five Thousand Pesos only (Php45,000.00), From Insurance Contributions Personnel Services to Cash Gift";

Moreover, disbursement of appropriation shall be made exclusively in accordance with the specific purpose for they have been appropriated within the limit of available resources of the barangay subject to the usual accounting and auditing requirements;

**WHEREAS,** subsequently, the said barangay Appropriation Ordinance was referred for review to the Committee on Budget, Finance and Appropriation, and after careful study and due evaluation, and taking into consideration the comments and recommendations of the Local Finance Committee as embodied in its report dated February 5, 2009, the said committee submitted a report recommending likewise that the said Barangay Appropriation Ordinance be declare operative as of the date of its approval, subject to the conditions contained in the report of the Local Finance Committee:

**WHEREAS,** considering the favorable recommendation of both the city's Local Finance Committee and the Sanggunian's Committee on Budget, Finance and Appropriation , as reflected in their respective committee reports, this august body has resolved to adopt this resolution in order to ensure the delivery of basic services and facilities in the Barangay.

**NOW THEREFORE,**


