**WHEREAS,** subsequently, the said barangay Appropriation Ordinance was referred for review to the Committee on Budget, Finance and Appropriation, and after careful study and due evaluation, and taking into consideration the comments and recommendations of the Local Finance Committee as embodied in its report dated January 28, 2009, the said committee submitted a report recommending likewise that the said Barangay Appropriation Ordinance be declared operative as of the date of its approval, subject to the conditions contained in the report of the Local Finance Committee;

**WHEREAS,** considering the favorable recommendation of both the city's Local Finance Committee and the Sanggunian's Committee on Budget, Finance and Appropriation, as reflected in their respective committee reports, this august body has resolved to adopt this resolution in order to ensure the delivery of basic services and facilities in the Barangay.

**NOW THEREFORE,**


