CRUZ, ANTIPOLO CITY, INVOLVING THE AMOUNT OF SEVENTEEN MILLION SIXTY TWO THOUSAND SIX HUNDRED TEN & 53/100 ONLY (Php17,062,610.53) PESOS , AS APPROVED BY THE SANGGUNIANG BARANGAY UNDER APPROPRIATION ORDINANCE NO. 04-2008 DATED NOVEMBER 19, 2008, AS OPERATIVE EFFECTIVE JANUARY 01, 2009, SUBJECT TO THE CONDITIONS IMPOSED BY THE LOCAL FINANCE COMMITTEE AS EMBODIED IN ITS REPORT DATED FEBRUARY 6, 2009.

WHEREAS, on November 19, 2008, the Sangguniang Barangay of Sta. Cruz, Antipolo City, enacted Appropriation Ordinance No. 04-2008, embodying the CY 2009 Annual Budget of Barangay Sta. Cruz, Antipolo City, with a total appropriation of Seventeen Million Sixty Two Thousand Six Hundred Ten & 53/100 (Php17,062,610.53)";

Cruz referred to the Local Finance Committee for comments and recommendations and the said committee submitted a report dated February 6, 2009, copy of which is hereto attached and made an integral part hereof, containing its comments and recommendations to declare the said barangay annual budget as operative effective January 01, 2009 subject to the conditions as embodied in the said report;

WHEREAS, subsequently, the said barangay annual budget was referred for review to the Committee on Budget, Finance and Appropriation, and after careful study and due evaluation, and taking into consideration the comments and recommendations of the Local Finance Committee as embodied in its report dated February 6, 2009, the Sanggunian's Committee on Budget, Finance & Appropriation submitted a report dated February 23, 2009 adopting the report submitted by the Local Finance Committee and recommending likewise that the said Barangay Annual Budget be declared operative effective January 01, 2009, subject to the conditions contained in the report of the Local Finance Committee;

WHEREAS, considering the favorable recommendation of both the city's Local Finance Committee and the Sanggunian's Committee on Budget, Finance and Appropriation, as reflected in their respective committee reports, this august body has resolved to adopt this resolution in order to ensure the delivery of basic services and facilities in the barangay.

NOW THEREFORE,


