### CITY RESOLUTION NO. 2009-068

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. DANILO O. LEYBLE, FOR AND IN BEHALF OF THE CITY, TO REQUEST FROM FILINVEST LAND INC. AND OTHER LAND OWNERS FOR A GRANT BY WAY OF DEED OF DONATION OVER A PORTION OF SEVERAL PARCELS OF LAND LOCATED AT SITIO COLAIQUE, BARANGAY SAN ROQUE, ANTIPOLO CITY, TO THE CITY GOVERNMENT OF ANTIPOLO AND FOR OTHER PURPOSES.

**WHEREAS,** a great number of our constituents who are devotees to Our Lady of Peace and Good Voyage take an annual journey as a sign of thanksgiving to commemorate a historical event, dubbed as "historical flight" from the Antipolo town proper to a remote place in Sitio Colaique, Brgy. San Roque, Antipolo, Rizal a relatively safe place for evacuation during the Second World War II, wherein Antipolo became the center of bombings second to Manila for the period of 3 years, from 1942 until 1945;

**WHEREAS,** the possible site donation by the Filinvest Land Inc. and other landowners within the vicinity and leading to the site will contribute to the potential development of Eco-Tourism in the area upon provision by the City Government of the needed infrastructure facilities;

**WHEREAS,** the aforementioned grant or donation will surely benefit our constituents and the would-be tourist as soon as developments are undertaken, specially the construction of roads which will lead to the physical accessibility of the place;

**WHEREAS,** in order to attain the foregoing objectives, there is a need to adopt a resolution authorizing the City Mayor to make such representation with the Filinvest Land, Incorporated and nearby landowners.


**NOW THEREFORE,**






