CITY RESOLUTION NO. 2009-070

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND ENTER INTO, FOR AND IN BEHALF OF THE CITY, A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE (DA) CONCERNING THE ESTABLISHMENT OF A BAGSAKAN CENTER IN THE CITY OF ANTIPOLO, PARTICULARLY THE CITY MALL OF ANTIPOLO LOCATED AT OLALIA ROAD, CORNER NHA AVENUE, BARANGAY DELA PAZ, ANTIPOLO CITY AND FOR OTHER PURPOSES.

WHEREAS, the Department of Agriculture (DA) is in the process of implementing Goal 2 Program specifically addressing the five (5) major concerns of the AFMA namely: Profitability of Farmers, Global Competitiveness, and Sustainability providing sufficient, quality and low-priced wage goods;

WHEREAS, the DA is likewise implementing the "Bagsakan Centers and Barangay Bagsakan Projects" to make food accessible to the consumers and link the production area to the market outlets; and in order to ensure that the operation of the said project is fully and properly implemented, the DA has created the so-called National and Regional Food Terminal Teams;

WHEREAS, the DA has committed the needed facilities to reduce post-harvest losses and ensure quality and safe food;

WHEREAS, the Local Government Units (LGUs) are tasked to develop a comprehensive and integrated program that would provide economic growth and promote the welfare of its constituents, and the City of Antipolo, for its part considers the Bagsakan Center Project as one way of achieving this goal and therefore desires to participate in its implementation by designating the City Mall of Antipolo as the proponent/recipient of the Bagsakan Center Project;

WHEREAS, the establishment of a bagsakan center will ensure the sufficient supply of quality and low-priced commodities not only to the constituents of the City but also the public in general, for which reason, this august body has recognized the pressing necessity for the adoption of this resolution.

NOW THEREFORE,

ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to authorize, as it is hereby authorized, the Hon. Danilo O. Leyble, City Mayor, to sign and enter into, for and in behalf of the City, the Memorandum of Agreement (MOA) with the Department of Agriculture (DA) concerning the establishment of a BAGSAKAN CENTER in the City of Antipolo, particularly the City Mall of Antipolo located at Olalia Road, corner NHA Avenue, Barangay Dela Paz, Antipolo City, and for other purposes.




