LEYBLE, CITY MAYOR, TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY, WHATEVER DOCUMENT NECESSARY FOR THE ACQUISITION BY THE CITY OF THAT 99.71 SQUARE METER PARCEL OF LAND SITUATED AT M. L. QUEZON ST. CORNER SEN. LORENZO S. SUMULONG MEMORIAL CIRCLE (SANTIAGO'S FURNITURE SIDE) OWNED BY AND REGISTERED IN THE NAME OF GRANDWORTH RESOURCES CORPORATION, EMBRACED IN TCT NO. 323632, TO BE USED FOR THE CONSTRUCTION OF A TURNING BAY TO EASE TRAFFIC ON THE AFORESAID AREA, AND FOR OTHER PURPOSES.

N O W T H E R E F O R E ,


