WHEREAS, the City of Antipolo has likewise manifested its desire of establishing sisterhood relations with Marikina City, having a mind the process how Marikina City became progressive and developed in so short a span of time, for which reason, the august body has recognized the very pressing importance of establishing the said relations to enable both cities to learn from each other’s better practices in the field of local governance which will eventually lead to the promotion of the general welfare.

Danilo O. Leyble to enter into a Memorandum of Agreement for the purpose.
