### CITY RESOLUTION NO. 2009-081

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO NEGOTIATE FOR THE ACQUISITION OF A PARCEL OF LAND SITUATED AT TUBIGAN, BARANGAY DALIG, ANTIPOLO CITY, OWNED BY MELATHEL CORPORATION, CONTAINING AN AREA OF 7,162 SQUARE METERS, FOR PUBLIC USE OR PURPOSE.

Dalig, Antipolo City, had been served a Notice to Vacate Upon Writ of Execution dated September 10, 2008 by the Ex-Officio Sheriff, in connection with Civil Case No. 3583 for forcible entry as a result of the Writ of Execution issued by Hon. Antonio M. Olivete, Judge, MTCC Br-1, City of Antipolo, dated July 9, 2008;

**WHEREAS,** as a result of the issuance of such writ, the Samahang Maralita ng Dalig I consisting of more or less 100 families, and represented by its President, Lorna L. Pasigue, wrote a letter to the City Mayor, Hon. Danilo O. Leyble, thru the Sangguniang Panlungsod, earnestly requesting the City Government to acquire the property situated at Tubigan, Dalig, Antipolo City, with a total area of 7,162 square meters, owned by Melathel Corporation, to be used as relocation site for the more or less, 100 families who are members of the said association and who had been forced to vacate the area they were once occupying as a result of the decision rendered in the aforementioned civil case;

**WHEREAS,** the Melathel Corporation has manifested already its willingness to sell the subject property to the City Government of Antipolo;

**WHEREAS,** in order for the City to validly and legally acquire the said property, there is a need for the adoption of a resolution authorizing the local chief executive to negotiate with the owner for the acquisition of the said property;

**WHEREAS,** considering the very pressing importance of such acquisition in order to address the problems and concerns of the 100 families affected, this august body has recognized the need for the adoption of the required resolution conferring the necessary authority to the city mayor to negotiate with the owner for the acquisition of the subject property.

**RESOLVED FINALLY,** to furnish copies of this resolution to all concerned parties for their information and guidance.




