CITY RESOLUTION NO. 2009-087

A RESOLUTION EARNESTLY REQUESTING THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) TO DONATE IN FAVOR OF THE CITY GOVERNMENT OF ANTIPOLO THE ROADS AND OPEN SPACES FOUND IN BAGONG NAYON I, BARANGAY BAGONG NAYON, ANTIPOLO CITY, AND FOR OTHER PURPOSES.

WHEREAS, on March 15, 2000, the City Council adopted City resolution No. 43-2000 entitled "*A Resolution Earnestly Requesting the Government Service Insurance System (GSIS) to Donate or Partially Turn-Over to the City Government of Antipolo the Open Spaces Specifically the Playground/Plaza, Place of Worship and Helipad in the Subdivision Being Developed by the GSIS and New Solidcon via Joint Venture Project Agreement, and for Other Purposes*";

WHEREAS, in a letter dated March 9, 2009 of Manuel B. Almoguerra, President of the Bagong Nayon I (Antipolo, Rizal) Homeowners Association, Inc., Barangay Bagong Nayon , Antipolo City, addressed to the Hon. Danilo O. Leyble, City Mayor, copy of which is hereto attached and made as an integral part hereof, Mr. Almoguerra pointed out the pressing necessity of updating City Council Resolution No. 43-2000 as per manifestation of the GSIS Board of Trustees in order for the GSIS to approve the request for the turn-over to the City Government all open spaces found in Bagong Nayon I, Barangay Bagong Nayon, Antipolo City, as provided for under Section 33 of Batas Pambansa Bilang 220 which states:

"The owner or project developer shall donate the roads and open spaces found in the project to the local government of the area after their completion had been certified to by the Commission and it shall be mandatory for the said local government to accept such donations. Parks and playgrounds maybe donated to the duly accredited Homeowners Association of the project with the consent of the city or municipality concerned";

WHEREAS, cognizant of the aforesaid requisite, the abovenamed homeowners association is asking the City Government, thru the City Council for the updating and/or renewal of the aforesaid City Resolution No. 43-2000 to satisfy the requirements of the GSIS to enable the association to realize its long-time dream of having a community facility such as a multi-purpose covered court built in the area to better serve our constituents;

WHEREAS, acting on the said request, the Committee on Housing and Land Utilization , to which was referred the same request for appropriate action, submitted a report strongly and favorably recommending the adoption of the corresponding resolution to address the concern of the association , which was unanimously adopted by the august body;

WHEREAS, considering the various benefits that will redound to the city and its constituents in the event this endeavor is brought to its successful completion, this august body has recognized the pressing necessity of adopting this resolution.

ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to request, as it is hereby earnestly requested, the Government Service Insurance System to donate in favor of the City Government of Antipolo the roads and open spaces found in Bagong Nayon I, Barangay Bagong Nayon, Antipolo City and for other purposes.






