**WHEREAS**, on November 24, 2008, the City Council of Antipolo adopted City Resolution No. 2008-238 entitled "A Resolution Ratifying the Terms and Conditions of the Term Loan Agreement Entered Into by the City Government of Antipolo Involving the Amount of P750,000,000.00 with the Development Bank of the Philippines (DBP) " in order to finance the education related projects of the City Government which covers the construction of school buildings, land acquisition, and other related expenditures;
