CITY RESOLUTION NO. 2009-089

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, FOR AND IN BEHALF OF THE CITY, TO REQUEST THE HON. ROSARIO C. URIARTE, CHAIRMAN OF THE BOARD OF DIRECTORS, PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO), FOR THE ACQUISITION OF TWO (2) UNITS AMBULANCE TO AUGMENT THE HEALTH SERVICES OF THE CITY GOVERNMENT, AND TO ENTER INTO ANY AGREEMENT/DEED/CONTRACT IN FURTHERANCE OF THE AFOREMENTIONED PURPOSE.

WHEREAS, one of the major thrusts of the City Government of Antipolo is to ensure that basic social services in education, social welfare, livelihood and health care are made available to the underprivileged and less fortunate constituents of the city;

WHEREAS, with an estimated population of nearly 700,000 people, the two (2) units of ambulance being used by the City Government in transporting patients for medical treatment is obviously insufficient to meet the needs of our constituents;

WHEREAS, considering the very pressing necessity of addressing the said health concerns of the city, the honorable city mayor in a letter dated March 18, 2009 addressed to Hon. Rosario C. Uriarte, Board Chairman, Philippine Charity Sweepstakes Office (PCSO), copy of which is hereto attached and made as an integral part hereof earnestly requested the Hon. Uriarte for two (2) units of ambulance in the form of assistance to augment the health services of the City Government;

WHEREAS, in order to facilitate the success of the aforesaid worthwhile undertaking, there is a necessity to clothe the local chief executive with the necessary authority to hold talks with the Hon. Uriarte for the aforementioned purpose;

WHEREAS, considering the wide range of benefits that will redound to the city and its constituents in terms of better delivery of basic health services and facilities in the event the acquisition of two (2) ambulance units is brought to its successful completion, this august body has recognized the need for the adoption of this resolution.

ALL PREMISES CONSIDERED, ON MOTION MADE AND DULY SECONDED, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL IN SESSION ASSEMBLED, to authorize, as it is hereby authorized, the Hon. Danilo O. Leyble, City Mayor, for and in behalf of the City, to request the Hon. Rosario C. Uriarte, Chairman of the Board of Directors, Philippine Charity Sweepstakes Office (PCSO), for the acquisition of two (2) units ambulance to augment the health services of the City Government, and to enter into any agreement/deed/contract in furtherance of the aforementioned purpose.

RESOLVED FINALLY, to furnish copies of this resolution to all concerned parties for their information and guidance.


