### CITY RESOLUTION NO. 2009-009

**A RESOLUTION AUTHORIZING THE CITY TREASURER TO UNDERTAKE LEVY PROCEEDINGS OVER THE PROPERTY SITUATED AT BLOCK 4, LOT 33, SITIO MANGGAHAN, BARANGAY SAN LUIS, ANTIPOLO CITY, OWNED BY THE SPOUSES EPIFANIO J. ALANO AND CECILIA ALANO, CONTAINING AN AGGREGATE AREA OF 97,504 SQUARE METERS, AND FOR OTHER PURPOSES.**

**WHEREAS,** in two (2) letters both dated November 17, 2008 of Edgardo T. Cruz, Officer-in-Charge, Urban Settlement and Development Office (USDO), one of which is addressed to Hon. Jesus Angelito Y. Huertas, Jr., Chairman, Committee on Housing and Land Utilization, and the other Josefina O. De Jesus, City Treasurer, Mr. Cruz requested Hon. Huertas for the adoption of a resolution authorizing the conduct of levy proceedings over the properties situated at Block 4, Lot 33, Sitio Manggahan, Barangay San Luis, Antipolo City, owned by the Spouses Epifanio J. Alano and Cecilia Alano, for reasons that the owners of the said properties containing an aggregate area of 97,504 square meters had been delinquent in the payment of their real estate tax liabilities. Moreover, in letter addressed to Ms. De Jesus, Mr. Cruz requested the City Treasurer to undertake the necessary levy proceedings over the subject properties for eventual distribution to the residents in the area who are actually and presently occupying the subject properties;

**NOW THEREFORE,**


