### CITY RESOLUTION NO. 2009-010

A RESOLUTION APPROVING FOR PURPOSES OF REVIEW, BARANGAY DALIG ORDINANCE NO. 2008-003 ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON FROM USING PUBLIC ROADS FOR ANY OTHER UNDERTAKING NOT IN LINE WITH ITS APPROPRIATE USAGE, PROVIDING PENALTIES FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES, FOR BEING CONSISTENT WITH LAW OR ORDINANCES.

**NOW THEREFORE,**


